

2018 Bay Boat Dolphin Tournament

1. Entry fee shall be \$300.00 per boat.
2. This is a boat tournament and there is no limit on the number of participants per boat. All participants must sign an entry form. All persons on the boat must be registered. All fishing must take place on the registered boat. Substitution of a boat during the tournament must be approved by the rules committee. All participants are required to have the necessary licenses or permits.
3. All Fish must be caught between the hours of 7AM and 3PM. No transferring of fish or participants between boats is allowed.
4. All fish must be weighed in the presence of a registered participant who was on the boat the day it was caught.

Fish must be in fresh, edible condition and caught on rod and reel. No mutilated fish. Fish may be subject to inspection by a Torry meter. Any fish may be cut open. If a fish is determined to be unacceptable by the tournament committee it will eliminate the boat from the tournament.

5. In the event of a tie the boat weighing in first shall be the winner. Weigh scale will close at 5PM. The awards ceremony shall be immediately following the weigh-in at Angler's House Marina.
6. Captains are ultimately responsible for their crew and should make decisions as to safe sea conditions for their vessel.
7. A bay boat is defined by a low gunwale raised forward and aft deck. Single Outboard.
